acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death.
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.
3. I willingly agree to comply with terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE PARTY PEOPLE INC, its officers, officials, agents and/or employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (RELEASEES), from any and all claims, demands, losses, and liability arising out of or related to any INJURY, DISABILITY OR DEATH I may suffer, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

1. DHS Gradnite Registration Agreement must be completed and on file. Students will not be admitted to Gradnite without the completed forms.
2. Check-in is on Saturday, June 1, 2019 from 9:30 pm to 11 pm. Doors close promptly at 11.
3. A call will be made to the telephone number listed on the form when the graduate arrives.
4. Personal items should be left at home. Attendees will be allowed to carry a cell phone. All jackets, sweatshirts, purses, backpacks, etc. will be checked and kept in a secure location. Should an attendee need something from a purse or jacket pocket, they will be allowed to access their item, with an adult present. Gradnite is not responsible for any personal items that are brought to Gradnite. All attendees and their possessions are subject to search.
NO DRINKS OR DRINK CONTAINERS ARE ALLOWED. Inappropriate items will be confiscated. No weapons allowed.
5. Dress code is comfortable. Note that closed toe shoes are **REQUIRED** for some activities.
6. The use or possession of alcohol or drugs **WILL NOT** be tolerated. Attendees found in possession of or showing the effects of alcohol and/or chemicals upon arrival or during the event will be detained until a parent/guardian arrives to pick them up. No re-admittance will be allowed. Parents will be contacted immediately if an attendee is under the influence.
7. Attendees are expected to remain at the event until 5:00 am on 6/2/2019. If it becomes necessary for an attendee to leave because of illness, emergency or other circumstances, a parent/guardian will be contacted to come to the venue to pick him/her up.
8. No re-admittance will be allowed for anyone who leaves the event early.
